NOTE: The City of Rising Sun/Rising Sun Lion's Club presents the fireworks portion of the Stars & Stripes event. Weather-related rescheduling or postponement of the fireworks may not be made until late afternoon on the day of the event. The Stars & Stripes Committee independently determines whether or not to continue with the entertainment & vendor portion of the event.

#### 1. FESTIVAL HOURS: DATE & TIMES BOOTHS ARE TO BE OPEN

**Festival Date: Saturday, July 6, 2024: Booths must be open 4-10 p.m. (Vendors can elect to remain open during the fireworks.)** All vendors must furnish and set up all their own display items including tables, chairs, tents, etc. Arts, crafts, information, commercial and food booth space is available on a first-come, first-serve basis. There is a \$25 fee for arts/craft/info vendors and \$100 fee for food trucks/trailers. Vendors must be pre-approved by the Stars & Stripes committee to minimize duplication of food/merchandise. All food trucks must operate by generator.

Flea market items or excessive duplicate arts/craft vendors will not be permitted. "Duplicate" merchandise includes more than one vendor offering the same product brand such as Thirty-One, LuLaRoe, etc. and/or an abundance of the same types of items such as essential oils or jewelry (as examples.)

Food booths space is limited. To minimize food-type duplications, applicants must be approved by the Stars & Stripes committee. Food vendors must provide a Certificate of Insured with the City of Rising Sun (PO Box 38, Rising Sun, IN 47040) and Ohio County Tourism (PO Box 112, Rising Sun, IN 47040) as added insured. The Ohio County Health Department will be on site to inspect all food vendors before allowed to serve. After sending your application to Stars & Stripes, please contact the Health Dept. at 812.438.255 to learn of all required local/state guidelines including purchasing an Ohio County permit. The permit fee is paid to the Ohio County Health Department and is not included in the \$100 vendor fee.

<u>SET-UP:</u> Saturday, July 6, 2024 from 11:00-2:00 p.m. You will be met by one of the event staff or volunteers upon arrival. Vendor spaces will be assigned. Due to bands performing under the Main Street Pavilion, parts of Main Street will be CLOSED and inaccessible this year. Food trucks will be notified if the Health Department is going to schedule a specific time to be in the event area for inspections.

All vehicles must be moved to a designated parking area by 2:30 p.m. on Saturday afternoon. NO EXCEPTIONS DUE TO SAFETY REASONS. Any personal/bodily injuries or property damages arising out of or in connection with the use of vendor space caused by vehicles in the vendor area will be the sole responsibility of the owner of the vehicles.

#### 3. DEADLINE:

Vendor space is on a first-come, first-served basis until filled. Completed applications and waiver from Ohio County Tourism, Inc. must be received by Friday, June 14 at 4:30 p.m. at the Ohio County Tourism Visitors Center. The 2024 Stars & Stripes committee reserves the right to refuse any vendors due to space limitations or excessive duplicate food/merchandise. Applications with payment may be returned if received after event is filled.

#### 4. <u>FEES:</u>

\$25 per space free for arts/craft/information vendors. \$100 for food trucks/trailers. **Generators only**. No electric available. The event will be advertised within a hundred miles+ radius of Rising Sun, IN. Promotions by Stars & Stripes participants is greatly encouraged and appreciated! #### 5. BOOTH SIZE:

Booth size is approximately 10' wide X 10' long for arts & crafts. It is essential that displays conform to the exact space allotted (including trailer tongues and awnings). For safety purposes, once you are set up, you CANNOT drive vehicles in or out of the area. Selling is only to be done within your booth space. **NO ROAMING SALES ARE ALLOWED.** Please respect your fellow vendors. Violators using more than their allot space will be asked to leave.

#### **GENERAL BOOTH RULES:**

ABSOLUTELY NO OBSCENE MATERIALS, DRUGS, DRUG USE PARAPHERNALIA, ALCOHOLIC BEVERAGES, SNAPPERS, SWITCHBLADES, GUNS, AMMUNITION, STINK BOMBS, FIREWORKS, CANS OF HAIR COLOR SPRAY OR SILLY STRING. ANY TYPE OF UNLAWFUL OR POTENTIALLY DISRUPTIVE/DANGEROUS MATERIAL OR ACTIVITIES WILL NOT BE TOLERATED. ALL FOOD BOOTHS NEED TO SUBMIT A COPY OF THEIR INSURANCE WITH THE CITY OF RISING SUN & OHIO COUNTY TOURISM AS ADDED INSURED WITH THEIR APPLICATIONS. THESE RESTRICTIONS WITH BE STRICKLY ENFORCED.

- 6. NO FOOD OR BEVERAGES ARE TO BE SOLD AT THE STARS & STRIPES EVENT WITHOUT PRIOR APPROVAL OF THE FIREWORKS COMMITTEE. The Stars & Stripes committee has final approval of all items to be sold and booth set-ups. Any exhibitor found displaying items not shown on the submitted application or items against the Stars & Stripes event policy will be asked to remove offensive items, and/or will be prohibited from conducting further sales and/or be removed from the festival immediately. Volume of sound/music coming from booths must be kept at a reasonable level so as not to interfere with neighboring booths and paid performers. Stars & Stripes event personnel will be the exclusive judges of what is acceptable.
- **7.** <u>ARTS & CRAFTS:</u> General Rules Apply. The Stars & Stripes committee emphasizes quality craftsmanship and merchandise. A complete description of the items to be exhibited MUST be included on the application. In addition to your written description, please submit one (1) or more photograph(s) of items to be exhibited. Preferably the photo should show your entire booth set-up if possible. Multiple photos for promotional purposes on social media/print/websites are recommended. # 8. <u>COMMERCIAL, INFORMATION, NOT FOR PROFIT BOOTHS & VENDORS</u>: General Rules Apply.

**9.** <u>SECURITY</u>: No security will be provided for booth vendors. The 2024 Stars & Stripes committee, staff, or volunteers are not responsible for accidents or lost/stolen items under any circumstances.

#### 10. PLACEMENT:

Placement of exhibitors' booths is at the discretion of the Stars & Stripes committee. Exhibitor preference will be given first consideration based on space availability and vendor's applications that are received first. Location may be affected by special requirements such as physical needs, etc. Assigned spaces cannot be changed without the approval of the Stars & Stripes committee.

#### 11. ELECTRIC & WATER:

No electric or water is available for arts/craft/information vendors.

#### 12. TEARDOWN:

No early tear downs permitted. All booth displays and merchandise must be removed after close of the fireworks on July 6, 2024. Please do not attempt to move out of your location before this time. All exhibitors are required to clean up their own areas and put trash in the receptacles provided. Failure to remove all equipment and thoroughly clean up vendor area will result in a \$75.00

charge. The Stars & Stripes committee will not be responsible for storing, maintaining, or watching any items left at the festival area.

#### 13. CANCELLATION:

Please notify us as soon as possible if you have signed up to participate but will be unable to attend the Stars & Stripes event. Failure to do so may prevent a vendor from being allowed to participate in future events.

#### 14. SOUVENIR ITEMS:

Souvenir items that identify the Stars & Stripes event (such as T-shirts, mugs, buttons) will not be allowed for sale by any vendor unless specific written permission is received by the vendor from the Stars & Stripes committee prior to the event start date.

#### 15. BOOTH AGREEMENT:

Applications will be accepted on a first-come basis until filled. The Stars & Stripes committee will not supply tables, extension cords, etc. It is the applicant's responsibility to read and understand all regulations as outlined in this agreement. The Stars & Stripes committee is not responsible for accidents, damage, loss or injury of any kind. Business activity must be conducted in your assigned space only.

ABSOLUTELY NO ILLEGAL ITEMS, OBSCENE MATERIALS, DRUGS, DRUG USE PARAPHERNALIA, ALCOHOLIC BEVERAGES, SNAPPERS, SWITCHBLADES, GUNS, AMMUNITION, STINK BOMBS, FIREWORKS, CANS OF HAIR COLOR SPRAY, SILLY STRING. ANY OTHER ITEMS THE STARS & STRIPES COMMITTEE NIGHT MAY DEEM INAPPROPRIATE WILL NOT BE ALLOWED AND WILL BE ASKED TO BE REMOVED. THE STARS & STRIPES COMMITTEE HAS SOLE AND ABSOLUTE CONTROL OF ITEMS OR WARES OFFERED FOR SALE AT THE FESTIVAL. NO FOOD SALES ARE ALLOWED OUTSIDE OF DESIGNATED AREAS.

Trading or selling of contracted booth space is strictly forbidden. Exhibitors agree that the Stars & Stripes committee may revoke this agreement at any time, and for any reason without any financial restitution to the vendor.

THIS VENDOR AGREEMENT IS NON TRANSFERABLE.
